



Challenge

A full office overhaul of this scale comes with a complicated secondary problem: what happens to everything being replaced? Dechert needed to clear out an enormous volume of existing furniture — corner office sets, common area seating, and large-scale conference room tables — while simultaneously bringing in an entirely new look across the firm. Managing a project this large in the heart of downtown Philadelphia meant tight logistics, a need for speed, and a partner who could handle both the removal and the replacement without disrupting one of the city's most prominent law firms.

When Dechert LLP — a major law firm headquartered in downtown Philadelphia — set out to revamp their office, the scope wasn't limited to a single department or a single floor. Every corner office, every common area, and every large conference space across the firm's downtown Philadelphia office was on the table for a complete transformation.

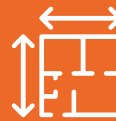
